

MEMORANDUM OF UNDERSTANDING

Between
MNR University, Sangareddy

And
MNR Hospital, Sangareddy

Date: 15.11.2025

1. Purpose

This Memorandum of Understanding (MoU) is made and entered into by and between **MNR University** (hereinafter referred to as “the University”) and **MNR Hospital** (hereinafter referred to as “the Hospital”) to establish a mutual collaboration for the provision of medical and healthcare facilities to the students, faculty, and staff of the University.

2. Scope of Collaboration

Both parties agree to collaborate in the following areas:

1. Provision of **outpatient and emergency medical services** to University students, faculty, and staff.
2. **Referral and hospitalization services** at concessional or agreed rates.
3. Conduct of **medical check-ups, health awareness programs, and vaccination drives once in six months** on the University campus.
4. Facilitation of **medical camps, first-aid training, and mental health counselling, and emotional wellness sessions**.
5. Sensitisation of various lifestyle and health problems.
6. Organising health research and Innovation programs to the students
7. Collaborative CSR projects in health care & Sanitation.
8. Establishment of a **University Health Centre/Clinic** with technical support and periodic supervision by the Hospital.

3. Responsibilities of the MNR Hospital

- Provide qualified medical personnel as per ICMR guidelines and necessary facilities for consultation and treatment.
- Offer emergency medical care and ambulance services as per availability.
- Maintain confidentiality of medical records and patient information.
- Provide annual reports on the medical services rendered to the University community.

4. Responsibilities of the University

- Facilitate the MNR Hospital in setting up medical camps and clinics within the campus when required.
- Promote awareness among students and staff regarding the available medical services.
- Provide necessary infrastructure or logistical support for on-campus health programs.
- Ensure timely settlement of payments or service charges as agreed upon by both parties.

5. Financial Terms

The terms of payment, discounts, or cost-sharing arrangements shall be mutually decided as 20% discount on present tariff.

6. Duration and Renewal

This MoU shall remain in force for a period of **five years** from the date of signing and may be renewed or extended upon mutual consent in writing by both parties.


7. Termination

Either party may terminate this MoU by giving **60 days' written notice** to the other party. In case of termination, both parties shall ensure that any ongoing activities are completed or properly closed.


8. Miscellaneous
