Any request beyond the specified period shall not be considered. On receipt of the requests from the students for re-evaluation through the concerned Deans, the University shall arrange to send such papers for re-evaluation to the approved panel of evaluators”.*

Accordingly, the Dean, SOET is also requested to inform students on the above re-evaluation provision as well as Supplementary Examination and required payment as per the Student Examination Registration Schedule notified vide Ref.4. The payment dates for these provisions will be notified later.
